# President's Message

It seems like forever since I wrote my last message for the February issue of this newsletter, and I admit that I have been putting off writing this one.

We held our first ever virtual chapter meeting on April 8, which was attended by ten members and ten guests. Thanks go to our speaker, Deneen Troupe-Buitrago, who hosted us on her Zoom account. Our plan is to hold our May 13<sup>th</sup> meeting at the Holiday Inn in person, although we will still be using social distancing protocols. I will keep the chapter updated on that meeting via e-mail, and I hope you will join us.

National Executive Director René Street held a webinar on Thursday, April 9, a recording of which is available on Community Connections in the National Resources. Some very important announcements:

- The current National Board of Directors will be serving a second term since many chapters were not able to meet in person to vote to sponsor a candidate, and the inperson interviews (required) of the six District Vice President candidates by the top three officers could not be completed.

Other important updates:

 The Eastern Michigan Council event to honor the chapter Women of the Year, Top Ten candidates, and Protegé recipients has been moved from April 18 to Saturday, June 13, 9:00 a.m. to noon. Novi Oaks is hosting this meeting at the Uptown Grill on Maple Road between Haggerty and M-5. I realize more every day that there are so many things that I normally take for granted, and that I am blessed in more ways than I can count.

Crazy, but on April 22, I am watching the snow fall again. I pray that you and yours stay safe and healthy, and I look forward to the day that we can be together again.

## Learning about ABWA: Opportunities within the chapter

#### **Chapter Executive Board**

Traditional chapters in ABWA have four officers: President, Vice President, Secretary, and Treasurer. A Nominating Committee of three members is appointed at the March meeting, who contact all members with at least one year of membership to find out if they are interested in running for office.

The Nominating Committee presents the slate of candidates in April and the election is held in May. The newly elected officers meet with the existing board in May, June, and July to transition, and to establish goals for the following ABWA year, which runs from August 1 through July 31. In 2020, the new board will be installed at the July 15th Night of the Stars celebration.

Any board member may hold a particular office for a maximum of two years.

#### Chapter Committees / Committee Chairs

The chairs of the various committees work with the board to make plans for the ABWA year, and to reach goals throughout the year. For Novi Oaks, the Standing Committees are as follows. If you are interested in working on any committee. please let the board know.

Membership - Chris Struwe: Collaborates with the board in maintaining the strength and vitality of the chapter by organizing and implementing a minimum of two membership recruitment campaigns (fall and spring) to attract new members and regain former members. Follows up with new members, and coordinates new member orientations (ABWA Aware & Share events).

Programs / Professional Development - Marcia Green: Delivers business and market-relevant programming at each monthly meeting. Uses the aggregate results from ABWA's Member Interest Survey to determine the programming topics that would best meet the needs of members and serve ABWA's mission. Stays within the budgetary guidelines and submits program information to the newsletter chair (speaker's name, photo, presentation title and overview, date and time).

Newsletter - Marcia Green: Designs, writes, publishes, and distributes the chapter newsletter to members, District Vice President, and to ABWA National. The newsletter should be published quarterly and either emailed or posted in Community Connections. Submits all newsletters for the Chapter's Best Practices Binder.

Fundraising - Chris Struwe: The one main fundraiser for Novi Oaks is the Autumn Brunch With Auction (see info at right). It is requested that all Novi Oaks members serve this project by

obtaining donated new items for the silent and live auctions, inviting guests, hosting a table (if possible), setting up the event the night before (or morning of), and attending and working during the actual event.

Publicity - Holly Hengstebeck: Coordinates the development of a plan that increases the visibility of the Chapter's notable initiatives within the community (e.g., write and send promotional information to community social and media outlets) and to maintain the Chapter's website, Instagram, and Facebook content.

Education - Karen Wernette Kolc: Serves as a liaison between the Chapter and the Stephen Bufton Memorial Educational Fund. The **Education Committee shall:** 

- · Monitor the league's contributions to the fund, and the amount of scholarships awarded for the Award Year.
- · Manage Impact Scholarships including the criteria for each scholarship sponsored.
- Submit applicant(s) for the Business Skills Tuition Reimbursement program to jmiller@abwa.org.
- Monitor scholarship applicants' fulfillment of the online application process.
- Report status on initiatives to the Chapter's Executive Board.
- Provide end-of-year written summary of activities and accomplishments to the Executive Board to be placed in the Best Practices submission notebook.
