There were 279 items up for bid and we raised \$12,600 after expenses. We had so many donations that we had to hold some items back, which gives us a hefty head start on next year's auction. Yay!

We are waiting to hear if we will have Saturday, October 12 or 19, 2024, for next year's auction. We are going with a later date because the 75th Anniversary National Women's Leadership Conference will be on September 25 through 28 in Overland Park, Kansas, and we want at least eight of our members to attend that event.

As always, we are so grateful for all the people who worked to make this event a success, including the owners and staff of the Burton Manor. The continued generosity and dedicated support of area business people, our members, family, co-workers, neighbors, and friends keeps this event alive.

We have funded the 2024 \$1,000 Bettie Archer Johnson Scholarship at Madonna University and two \$2,000 Impact Scholarships for 2024 through the ABWA Stephen Bufton Memorial Educational Fund (SBMEF). Applications open up on January 1, 2024.

We will also sponsor a candidate for the 2024 \$2,000 Outright Grant program at a cost of only \$150 to the chapter. Receipt of the grant is not guaranteed because one recipient will be chosen for each of the six districts of ABWA by the National Board of Directors. District V includes Michigan, Ohio, Indiana, Kentucky, and West Virginia.

Novi Oaks also offers a Business Skills Tuition Reimbursement program and provides funds for members to attend regional and national ABWA conferences.

Rosie the Riveter Presentation at Novi Oaks' November 8th Meeting

The room was full of energy as guest speaker Jeanette Gutierrez (pictured bottom center) from the American Rosie the Riveter Association (ARRA) at Willow Run presented, "Rosie the Riveter and Beyond: How Women Helped Win WWII." The ARRA includes not just the women who worked in the factories, but also those who served as pilots and in offices. Without all of the women who entered the workforce, the war would not have been won. Novi Oaks voted to make a \$200 donation to the ARRA.

The fact that so many women started working outside the home during those years changed American society as women learned that they liked working and earning money. The American Business Women's Association was founded in 1949 due to the number of women working.

Sharon Cressman was one of Pat Plamondon's guests. Sharon's mother was Alvina R. Frisch, who passed away in October this year at the age of 100. Her obit noted, "During WW II, Alvina worked at Twist Drill in Rochester Michigan; she was a true Rosie the Riveter!"

Karen Kolc's sister, Dawn Wernette-Leff, and brother, Michael Wernette also attended. Their grandmother, Dr. Nola Wernette, worked on the navigation boards/desks for the planes out at Willow Run. She had a doctorate in education (one of 7 higher degrees from high school to college) had 5 children, was vice principal of 2 Detroit Public Schools, and lived to be 100.5! Karen was her caregiver until she took her very last breath. See picture below left.

Jeanette also brought a certificate to honor our chapter founder, Bettie Archer Johnson (1923-2017), who was a WWII Navy WAVES veteran and had worked as a telephone operator in New York City. Bettie remained active in her Navy WAVES organization for 70 years, served on the board for the Great Lakes National Cemetery, and was also a Representative of the Women In Military Service Memorial at Arlington Cemetery. She was a proud veteran and loved women, the United States, and ABWA with all of her being.

Our Checklist to track progress for Best Practices 2023-2024



Our 2023-2024 ABWA year runs from August 1st through July 31st. For 2022-2023, we earned a Level III Best Practices Award, which was presented to 2022-2023 President Holly Hengstebeck, VP Chris Struwe, and member Sheri Mayer on stage in Chattanooga at the National Women's Leadership Conference in October.

REQUIREMENTS FOR BEST PRACTICES:

By June 30, 2023, submit to ABWA National:

- ☑ Names of officers for 2023-2024 (four required).
- ☑ All officer positions are filled (four).
- ☑ \$125 chapter liability insurance fee.
- ☑ Website listing: Must meet branding standards and have required elements (links).
- ☑ Submit of committee chairs to ABWA by August 15, 2023.
- ☑ File 990-N tax return for 2021-2023 by <u>December 15, 2023</u>. By July 31, 2024:
- Have at least 30 members in good standing (national and local dues paid). We currently have 33 members.
- □ Recruit at least 6 new members (at 3 new members now).
- $\ensuremath{\overline{\mbox{\square}}}$ Officers and committee chairs in good standing (dues paid).
- ANNUAL PLANNING:
- ☑ Have a minimum of 10 members complete the Member Interest Survey (we had 14).
- Create a Vision Statement and put it on the Community Connections Team Board.

EXECUTIVE BOARD ITEMS:

- ☑ Complete a chapter GAP Analysis.
- □ Develop an annual business plan, action items, budget, and executive summary.
- Complete a Competitive Analysis of women-centered organizations in the community where your League meetings are hosted.
- ☑ Create action items (Key Results Areas / KRA's).

ALL CHAPTER MEMBERS:

- ☑ Vote to approve the annual budget.
- ☑ Vote on the League's Standing Rules (including adopting ABWA's Proud Code of Conduct and Core Values).
